## Executive Director's Report - January 2019

## 1. Residents

a. Two residents have passed away in January.

## 2. Staff

a. For our Christmas party, 28 of us went to Jubilations Theatre for an evening of food and fun. It was a great time!

## 3. Waitlist

a. 53 people have put down the \$500 deposit and expressed their desire for the North Wing. Some have other options listed as well (ie. East Wing), but this is encouraging!

# 4. Brad Kotowich

- a. I've had three meetings with Brad since our November Board meeting. The third meeting was also with our entire management team, last week Tuesday. Discussions focused on:
  - i. Leadership vs. Management
  - ii. Organizational Sustainability & Health throughout a Growth strategy
  - iii. Individual Job Purpose Statements and Outcomes
    - 1. Lots of discussion around how we can hold each other accountable as a team, without emotions, if we all have clear outcomes for our individual roles. This will be one of the next pieces of homework for Brad and me.

## 5. MBA Group

- **a.** Part of the MBA program is a capstone course, where MBA students work with an organization for a semester (I completed my capstone course last year).
- **b.** I put the Society in as a potential sponsor, and we will have a group of 6 MBA students put together some work for us this spring. It isn't much work for us, but I will know more about the project later this month.

### 6. Security System

- c. Laura & I have met with prospective contractors and polished up a proposal that we are confident would provide us with a sufficient level of monitoring.
- d. We've been unable to follow these incidents up appropriately, and I'm concerned about how exposed our building is.
- e. If we do decide to put this project off for now due to cost, we should at the very least keep this as a top priority moving forward. I'll give more verbal commentary and some examples at the meeting!

## 7. Neerlandia

a. Meeting with the Neerlandia CRC congregation later this month to discuss the potential sale of the 3 acre site beside their church.

## 8. Leduc CRC

a. Meeting on January 13<sup>th</sup> with approx.. 35 people from the Ebenezer CRC congregation to discuss seniors housing as a potential project for that group, on the site that hosts their church and school.
