001	Main Floor Common Area Conflict	27-MAR-19 (GV) Review of the main floor common area determined that we were going to have conflict with glycol heating / cooling lines, sprinkler lines and ductwork coming out of mechanical room 105 and tucking under the main structural beam. Jetco had concerns with adding too many elbows to the glycol system at this location (air lock). It is not an option to lower the ceiling too much in this space as we are tight to the top of the exterior windows as is. It was proposed to relocate the glycol feeds to the other side of the window in this common area. Cormode to determine if 4 - 4" holes through structural slab would be acceptable.			New
002	Main Floor Corridor	27-MAR-19 (GV) Jetco provided a sketch showing proposed mechanical rough-in for review and consideration (see attached). Electrical to be installed above mechanical trapeze. Ductwork Rough in to be below. All drywall skirting and fire caulking to be installed before mechanical rough in starts.			New
003	Shower Deliveries	27-MAR-19 (GV) Cormode has asked that main floor and second floor showers be shipped to site on or around the 15th of April. Third and fourth floors can be scheduled to be shipped the week of May 13.			New
004	Ventilation Bulkheads (2,3,4)	27-MAR-19 (GV) For the mechanical bulkheads to the second, third and forth floor we need to maintain a maximum bulkhead depth of 220mm to the upper ceiling (see attached sketch) in order to avoid having to add additional sprinkler heads. Clearance from the underside of the bulkhead to the top of the door frame should not be an issue (see attached sketch).			New
005	Two Bedroom Pluming Wall	27-MAR-19 (GV) In the two bedroom suites we have plumbing stacks and vent stacks servicing the kitchen sink. We need to review if a false wall is required at these locations to run required pipes. It is not an option to run plumbing in cabinets.			New
