Report from the CEO's office

Good afternoon!

This past year has been full of change! COVID-19 has been in and around everyone's conversations and planning for 6 months now. I remember that first morning when the provincial decision was made to shut things down in response to the growing threat of COVID-19. Our leadership team sat around the table and had to make some difficult decisions without much information. At Emmanuel Home, we have a community of seniors who rely on regular contact and interaction with their dear loved ones. Two weeks prior, we had just hosted a town hall meeting about the potential West end expansion project and were gearing up to get the ball rolling on the project. We were two weeks away from opening the doors to the North Wing expansion project with almost all 50 suites ready to be filled in April. Discussions were ongoing with Neerlandia about a Christian seniors' home in that community. Needless to say, there was a lot going on that needed to be taken into consideration!

With thanks to the Lord, we can look back on the past year and see His faithfulness and provision despite the challenges we've all embraced. Overall, our residents at Emmanuel Home have been in good health and COVID free. Staff and residents have both taken on the challenges of new restrictions and protocols with a focused and common goal of protecting each other. While I don't want to minimize how difficult it has been for everyone, I do want to commend their willingness and diligence in adjusting to the new normal.

The doors to the new North Wing were opened on April 1st, and although the move-in process was slowed, we are almost full and have just a few suites left. We are looking forward to a big party or two to celebrate with you, whenever it is possible, but in the meantime all of Emmanuel Home residents are enjoying the beautiful common areas and our new residents are settling into their suites. We are also pleased to report that the project came in on budget.

Work continues on the design & development of our West end site. Successful re-zoning of the site is anticipated for this fall, at which point we will complete the purchase of the land. In the meantime, our Building Committee has been working away at designing the building and planning for the next steps in obtaining financing and permits for the spring of next year, Lord willing. 39 people have already signed up for the waitlist! Drawings and updated plans will be distributed later this fall. Keep an eye on our website for future updates.

I want to thank the community of Neerlandia for engaging in many thoughtful and serious conversations over the past year and a half. We have decided to put off the work in building and operating a home in that community for now, as the timing is not right to take the next step. However, the door remains open for firing this conversation back up in the future.

Our Life Lease program was launched at Emmanuel Home this past spring, and we have seen some uptake already by residents who are looking to lower their monthly costs by participating in the program. 2020 Board Nominees

Kelvin VanDasselaar - 8 month extension

Kelvin has served as our Board President for the past 4 years. With the current Board turnover and make-up, the Board is presenting the Society with the decision to extend Kelvin's tenure by 8 months, even though he has completed two 3-year terms. Kelvin is willing to remain on until next spring's AGM to foster a smooth transition for the next President and re-balance the amount of Board member turnover that will occur each year.

Allan Brennan - 3 year term

Allan trained to be a Quantity Surveyor (QS) with a firm in England. In 1977, after returning to Canada, he worked as a QS in Toronto, Thunder Bay, Winnipeg, Calgary and Edmonton. In 1989, he took employment as a Cost Manager (construction economist) with the Alberta Government. This role involved the budgeting for the construction and renovation of schools, hospitals and post-secondary education facilities. He retired from the Alberta Government in 2012.
